Chapter-I

INTRODUCTION AND VISION :

Rural India is the natural abode of over seventy per cent of our people who depend mainly on agriculture for their livelihood. The Government, in order to improve the lot of our rural populace, launched many programmes in the post-independence era. Co-operatives have played an effective role towards achieving the desired development in the agriculture and allied sectors.

The West Bengal Apex Co-operative Agricultural Marketing Society Ltd. was set up on 04.03.1958 under the-then Bengal Co-operative Act, 1942, as an Apex Society in the State of West Bengal for handling of systematic and orderly marketing of agricultural produces, supply of essential agricultural inputs and allied services through the network of the Primary Agricultural Co-operative Marketing Societies (PAMS) and Primary Agricultural Processing Co-operative Societies (PAPS), who were united to form the Apex Society. The name of the Organization was subsequently changed to the West Bengal State Co-operative Marketing Federation Ltd. in the early Seventies and thereafter from the end of Seventies/early eighties was given the acronym "BENFED".

2008 is the 50th year of incorporation of BENFED.

Chapter-II

Report

MEMBERSHIP AND EQUITY STRUCTURE

Membership of BENFED is open to the Co-operative Societies mostly linked with Agricultural Marketing in the State of West Bengal. It is divided into four classes. "A" Class Membership is open for Co-operative Marketing Societies; "B" Class Membership is open for Co-operative Agricultural Processing Societies. "C" Class Membership is open for the State Government of West Bengal and "D" Class Membership is open for the Co-operative Societies dealing in Agricultural Marketing and falling under categories other than those covered under "A" & "B" Class. However, the "D" Class Share holders are classified as "Nominal Members" without the right to vote in the AGM, without right to participate in the Management and without having any right to share the profit of the organization.

MANAGEMENT

The BENFED is managed by a Board of Directors comprising 19 (Nineteen) Directors. Out of the 19 Directors, 15 are elected, representing the "A" Class and "B" Class Share holders from different districts of West Bengal, 3 are nominated by the Government of West Bengal and one nominated by the Financing Bank, viz., the West Bengal State Co-operative Bank Ltd.

The Board of Directors has constituted two sub-committees – Administrative Committee and Business Committee to consider different issues related to administration and business in detail for recommending adoption of different policies and actions. Such Committees have been constituted to help Board take policy decisions etc. for running the Organization effectively and efficiently.

There is a Branch Advisory Committee (BAC) in every district to advise the District Branch of BENFED in its business administration.

THE JOURNEY SO FAR

Set up in 1958, BENFED started functioning from a small rented office in Dalhousie Square (East) at Kolkata. The organization was then named as "The West Bengal Apex Co-operative Agricultural Marketing Society Ltd.". There were only a handful of paid employees in the organization. There was a "Managing Committee" comprising elected representatives from the member Co-operative Societies. The administrative head of the organization was designated as "Secretary".

At the initial stage of operation, the major activities included distribution of Chemical Fertilizers under the distribution Scheme approved by the Reserve Bank of India. Gradually the realm of activities was extended to dealing in agricultural inputs, e.g., Seeds, Pesticides, etc.

The organization had opened its Branch Offices in different districts of the State. The green revolution ushered in the country opened up opportunities to the organization to expand its business activities. Subsequently, the organization's head office at Kolkata was shifted to bigger premises on rent at Ganesh Chunder Avenue at Kolkata. There was addition of new activities like procurement of agricultural produces, etc., from the farmers of the State. At this stage, the organization's name was changed to "The West Bengal State Co-operative Marketing Federation Ltd."

With the enactment of new Co-operative Law for the State of West Bengal in late '70s, the "Managing Committee" was started to be termed as "Board of Directors" and the executive head of the organization was designated as "Managing Director". The annual turnover of the organization shored up to over 150 Crores by then.

In the later part of '70s and in early '80s the organization adopted "Re-organization & Expansion Programme (REP)" to achieve more business turnover through adoption of modern management and business entrepreneurship in the organization. New business departments were created to manifold the activities of the organization for the future. At this juncture, the organization was given the acronym "BENFED", which it is called by in the present time.

With the introduction of Scheme sponsored by NCDC under financial assistance from IDA for construction of Storage infrastructure and Cold Storage infrastructure administered by NCDC, BENFED was given a bigger role of lending technical consultancy & supervision for implementation of the project. This necessitated setting up of an "Engineering Division" in BENFED. This paved the way of construction of large storing infrastructure for BENFED and two Cold Storage Units - one in Burdwan (Memari) and the other in North 24-Parganas (Mirhati). With the growth of business, the number of paid employees was increased to the level of 400 +.

However, in 1978, the Board of Directors of the organization was superceded under Government Orders. A legal battle ensued between the deposed Board of Directors and the State Government that rendered the organization being run by no democratically elected Management since 1981-82. During the intervening period, the Managing Director discharged the function as In-Charge of Management under the Orders of the Hon'ble High court at Calcutta. During this long period when democratically elected management was not in office, there was no "Annual General Meeting (AGM)" in the Organization.

In the mean time, the Head Office of BENFED was again shifted to a larger premises taken on rent at Poddar Court at Kolkata. The business turnover started increasing steadily and shored up to Rs.350 Crores.

The long legal battle ended in early '90s and the deposed Chairman of the BENFED was allowed to assume Office to pave the way for installation of democratic management in the organization. The long awaited Annual General Meeting was held in 1996. A democratic management assumed office in the organization. Subsequently, the democratic process of management is now in place in the organization and AGM is being held regularly as per requirement of law.

With the increase of business turnover and business activities, it was considered imperative that the Chief Executive of the organization should be an Officer from the Indian Administrative Service. Accordingly since 1976-77, the post of Managing Director is being occupied by Officers of Indian Administrative Service, barring short spells of time in between, when senior Officers from the Co-operation Directorate held the office of the Managing Director.

The new era in '90s witnessed New Economic Policy (NEP) adopted by the Union Government and there were major policy changes affecting economy of the country at large. The BENFED also had to change its way of activities. Policy changes were imminent and action on this direction was started to be taken. Apart from business augmentation, policy formulation and other initiatives, the major thrust was to consolidate its business. To have these objectives fulfilled, the BENFED purchased premises of its own at Kasba in Kolkata and got its Registered & Head Office shifted there for the future time to come. The BENFED is functioning from its new address as at present. Presently, the BENFED has 384+ employees in its pay-roll spread over its Head Office, District Branch Offices and Unit Offices. It has branches in every district of the state. The present business turnover of BENFED has crossed Rs 600 crore.

ADMINISTRATIVE SET-UP

As mentioned earlier, the administrative set-up of BENFED is headed by the Managing Director, who is the Chief Administrative Officer of the Organization. A senior Officer from Indian Administrative Service occupies the position of Managing Director, who is deputed by the Government of West Bengal. There are two Officers from State Service occupying the positions of General Managers in the organization.

The Head Office of BENFED is situated at Kolkata. It has got 18 (Eighteen) Branches all over the State. Each district has one Branch Office headed by the District Manager.

The Head Office consists of the following Divisions and Departments:

1. **Administration Division:** Headed by General Manager (Administration)
 - a) **Personnel Department** is headed by the Manager (Personnel). He works under the general control of the General Manager (Administration). The Personnel Department is responsible for looking after the service matters of the employees of the Federation.
 - b) **Administration Department** is headed by the Administrative Manager. The Administration Department is responsible for looking after different administrative matters. It also looks after the secretariat matters of the Board and various sub-committees constituted by the Board. The legal matters are also looked after by this Department. The Department is overseen by the General Manager (Administration).
2. **Marketing Division:** Headed by General Manager (Business)

The Marketing Division comprises of the following five Departments, viz.:

- (a) **Fertilizer Department** : The Department is headed by Manager (Fertilizer). The Department deals in the matters of procurement, supply and distribution of different chemical fertilizers through co-operative network in the State.
- (b) **Jute Department** : The Department is headed by Manager (Jute). The Department looks after procurement of raw jute from the cultivators at Minimum Support Price (MSP) directed by the Government of India and delivers the same to the Jute Corporation of India (JCI). The Department also undertakes commercial procurement

of Jute through affiliated/associated Co-operative Societies for sale of the fibre to the Jute Mills when the price of raw jute remains above the MSP.

- (c) **Marketing Department** : The Department is headed by Manager (Marketing). The Department is responsible for procurement of different agricultural produces, e.g., vegetables (mainly potato), grains, pulses & spices etc., except raw Jute, both at MSP and Market price for disposal in the open market or supply to the Government Agencies/ Departments as per instruction.
- (d) **Inputs Department** : The Department is headed by the Manager (Inputs). The Department looks after procurement, supply and distribution of different Agricultural Inputs, e.g., Bio-Fertilizers, Micronutrients, Insecticides, Pesticides, Herbicides, etc., through the network of Co-operative Societies.
- (e) **Commercial Department** : The Department is headed by Manager (Commercial). The Department is responsible for dealing in Farm Mechanization Equipments and ancillary items required for enhancing productivity by adoption of modern cultivation practices.
- (f) **Planning & Development Department** : The Department is headed by Manager (Planning & Development). The Department is in the look out of new business initiatives and identifying potential business activities beneficial to BENFED and its Member Co-operatives.

These Departments are overseen and their activities coordinated by General Manager (Business).

3. **ENGINEERING DIVISION**

The Engineering Division of BENFED has got two prime activities, viz., (i) rendering technical consultancy and supervision in project implementation to the Co-operative Societies in the State of West Bengal and outside the State of West Bengal & (ii) creation, maintenance and exercising functional control over the infrastructure and production/service units of BENFED. The Department is headed by the Engineer-in-Chief and supported by Senior Civil Engineer, Assistant Engineers, Junior Engineers and clerical staff. This division works under the overall superintendence and guidance of General Manager (Business).

4. FINANCE DIVISION

The Division is headed by Financial Advisor. The prime role of the Finance Division is to undertake management of funds of BENFED, looking after utilization and deployment of fund and harnessing external resources for providing finance for business operation. This Division functions under the overall superintendence of the General Manager (Business).

5. ACCOUNTS & AUDIT DIVISION

The Accounts & Audit Division is looked after by the Chief Accounts & Audit Officer (CAAO). The main function of the Division is to ensure timeliness in preparation of BENFED's Accounts and Audit thereof by the Directorate of Co-operative Audit. The day to day account matters are dealt with by the Accounts Officers and Assistant Accounts Officers of this Division. In addition there are Branch Accountants also in the district branches.

Internal Audit Department : The Internal Audit Department under the Audit and Accounts Division has got two prime role of enforcing pre-audit and internal audit of all transactions having financial implication in BENFED. With a dedicated pool of internal auditors, this Division is looked after by the CAAO. There is an Audit Committee in the HO, headed by the General Manger (Admn) that examines the audit reports and recommends necessary measures to the Management.

Besides the above administrative set up at BENFED Head Office, there are 18 Branches in 18 Districts of the State - each District having one Branch - and three Unit Offices at Memari in Burdwan District (2 Units) and Mirhati, Barasat in North 24-Parganas District (1 Unit).

The District Offices of BENFED are headed by the District Managers in the rank of Deputy Managers/Assistant Managers. The District Branches having turnover above 25 Crores, are headed by a Deputy Manger assisted by an Assistant Manager. In other districts Assistant Mangers are posted as District Mangers.

EMPLOYEES RECREATION/WELFARE ETC

THE RECREATION CLUB

BENFED has got at HO a Recreation Club of its employees. The club organizes cultural functions, annual picnic, Bijoya Sammilani, etc., to further the interest and taste of its members in cultural affairs.

THE COOP CREDIT SOCIETY

BENFED has got an Employees' Co-operative Credit Society at its HO. The employees of BENFED are members of the Society. The Society meets the occasional credit need of its members. This society is successfully managed within their limits & constrains and is earning profit as well. There is another cooperative credit society at Burdwan branch of BENFED also.

PAY, ALLOWANCES & FRINGE BENEFITS

BENFED as a structured organization follows time scale of Pay for different categories of posts and employees. A new Pay Structure for all categories of the employees has been introduced with effect from 1st April, 2008. Besides Pay and other usual allowances, the employees of BENFED are entitled to encashment facility of Earned Leave once in every calendar year, benefits of Contributory Provident Fund and Retirement Gratuity as per Payment of Gratuity Act, 1971.

The two General Managers of BENFED are posted by the State Government - one from the WBCS (Exec) cadre and the other from the West Bengal Cooperative Service. The Administrative Manager of BENFED is also on deputation from the West Bengal Cooperative Service. The post of Chief Accounts and Audit Officer (CAAO) has been created in BENFED during the last year by amalgamation of the posts of Chief of Finances and Chief Audit Officer. One officer from West Bengal Audit and Accounts Service has joined this position.

INFRASTRUCTURE AND ASSETS OF BENFED

BENFED has over a period of time acquired landed property in districts to promote

its various business activities.

BENFED has two cold storages - at Memari, Burdwan and at Mirhati, North 24 Parganas. The Memari cold storage is run by BENFED directly. The Mirhati cold storage has been given to a private enterprise under an Operation & Maintenance (O & M) Contract during the current year.

ACCUMULATED LOSS

The low margin in certain trade compared to the scale of investment, non-recovery of trade dues and high incidence of interest on Government and Bank Loan contributed to the formation of such accumulated loss. However, systematic and planned augmentation of business, efficient management of trade and financial resources, reduction of overhead costs as far as possible without compromising with the basic qualities and service, have been resulting into progressive reduction of accumulated loss.

The accumulated loss, calculated since 1981, was Rs 52.44 crore at the beginning of 2006-07. During 2006-07, Rs 33 crores was paid to WBIDFC through state government assistance by way of conversion of the outstanding Government Loan into Equity contribution from the State Government. During the current year a due of Rs 4.45 crore was settled with WBSCARD through OTS. The balance Rs 25 crores with an interest of Rs 55.28 crores remains outstanding. BENFED has moved the state government for OTS with a proposal to pay the half of principal with remission of interest on the overdue Government Loan.

It is anticipated that by the turn of the year 2009-2010, the accumulated loss in BENFED will turn minimal if not fully wiped out.

TURN-AROUND STRATEGY & CORPORATE GOVERNANCE

At the behest of the State Government in the Co-operation Department and with the financial assistance from the National Co-operative Development Corporation (NCDC), the Indian Institute of Management, Calcutta (IIM-C) has been working on a turn-around strategy for BENFED to cope up with the current changes in the marketing and financial environment. The initiative encompasses adoption of appropriate business strategy, improvement of HR through training and internal management changes, adoption of appropriate technology based on computer application, etc.

ANNUAL GENERAL MEETING & INTERACTION WITH THE MEMBERS & ASSOCIATED CO-OPERATIVES

The 25th Annual General Meeting of BENFED was held on 22.06.2008. During the Co-operative Year under review, 7 meetings of the BoD were held. Besides the above meetings, regular meeting with the Member Co-operative Societies were held in different Districts. During the year the Business Committee met 2 times and the Administrative Committee held 4 meetings.

ADMINISTRATIVE STREAMLINING MEASURES TAKEN UP DURING THE YEAR

- **Staffing Pattern:** A new staffing pattern has been adopted by BENFED during the year. As all the staff of BENFED are appointed centrally, there was a general lop-sided staff deployment across the districts with the districts closer to Kolkata having more staff than required and the far off districts having perpetual shortage of staff. The new staffing pattern has been developed keeping in view the size of the district and its business turnover. The accounts and audit set up of the district branches have been especially strengthened under the new staffing pattern.

- **Transfer Policy:** A new Transfer Policy was adopted by BENFED in 2008. The policy has been developed with consensus among the staff and officers of the organization. The current transfers are all based on the new policy.

- **Promotion Policy :** The last promotion that took place in BENFED was during the late eighties or early nineties. In the absence of any Promotion Policy the employees of BENFED were stagnating at the same level/rank for decades. Under its new focus on human resource development, BENFED developed a Promotion Policy in tune with its bye-laws and the WBCS Act and Rules. Large scale promotions took place under the new policy during the year. Staff across the board from Group D to Group A benefited from this new Promotion Policy.

- **Business Process Re-engineering:** The business activities of BENFED and associated office processes were examined to find out the areas of strengthening. This exercise coupled with the past experience, especially in the areas of business losses, led to initiation of several process-reengineering measures. This included new funding arrangements, reworking the business arrangement with partner cooperatives and business associates, planned fund management, simplified office procedures, delegation of powers, effective documentation and record keeping etc.

- **Merger of departments/creation of departments :** As a corollary of the business process re-engineering and administrative streamlining some of the existing Departments in the Head Office were merged and some new Departments were created to sharpen the

focus of the organization on new business opportunities. The Accounts Department and the Audit Department were merged as Audit and Accounts Department under the unified command of the Chief Audit and Accounts Officer. Similarly the Secretariat Department was merged with the Administrative Department. A new Planning and Development Department was created to look after the new business initiatives.

DIVERSIFICATION OF BUSINESS/NEW BUSINESS VENTURES:

BENFED has taken initiative to venture in a few new areas, viz., endeavour in production of quality seed of Paddy and other crops as may be feasible jointly with the Co-operative Societies and their members. For such business, pilot programme is being taken up in a few Districts on the basis of response from such Districts. The initiative will be translated into action in the next Co-operative year (2008-2009).

Endeavour is being made to promote setting up of Bio-Fertilizer Units and Vermicompost Units by the affiliated/associated Co-operative Societies at rural level. The product will be marketed by BENFED on sharing basis through Co-operative network.

Keeping with the market demand, the affiliated/associated Co-operative Societies are being enthused to take up primary processing activities of agricultural produces. This will help develop such affiliated/associated Co-operative Societies towards their viability. For such activities, BENFED will provide consultancy services and support for appropriate linkage for transfer of technology, etc.

Internal Audit system : The internal audit system of BENFED had become extremely weak over the years. BENFED had to hire CA firms to undertake its internal audit/running audit requirements. In order to overcome this problem, BENFED developed a strong Internal Audit Department in the HO with deployment of Audit Officer and Assistant Audit Officers under the unified command of the newly created post of Chief Audit and Accounts Officer, drawn from the WBA&A service. Now the district offices of BENFED are being audited round the year by its own internal audit teams. The reports of the internal audit teams are being placed in a newly formed Audit Committee of the HO for issuing necessary instructions and guidelines to the district offices as well as to HO.

Inspection System : The inspection system, involving inspection of the district branches by the officers of the HO was almost non-existent in BENFED. This system was re-introduced in the organization with senior officers of HO undertaking branch inspection twice a year. Necessary instructions and guidelines are issued to the district branches by the HO based on the inspection reports. These inspections are also helping BENFED take informed policy decisions on operational matters.
